**Release of Liability and Indemnity Agreement (All exhibitors & parents must sign)**

1. APPLICABILITY AND SCOPE OF RELEASES AND INDEMNITIES: FOR PURPOSES OF THE AGREEMENT, "CLAIMS" SHALL MEAN ANY PAST, PRESENT AND FUTURE CLAIMS, LOSSES, COSTS, EXPENSES, LIABILITIES, DEMANDS, OR CAUSES OF ACTION, AND COSTS OF DEFENSE OR SETTLEMENT (INCLUDING, WITHOUT LIMITATION, ATTORNEYS' FEES AND COURT COSTS). THE RELEASES, WAIVERS AND INDEMNITIES CONTAINED IN THIS AGREEMENT EXPRESSLY SHALL APPLY REGARDLESS OF WHETHER THE CLAIMS TO BE RELEASED, WAIVED OR INDEMNIFIED AGAINST ARISE, OR ARE ALLEGED TO ARISE FROM (I) NEGLIGENCE (WHETHER SOLE, JOINT OR CONCURRENT), GROSS NEGLIGENCE, NEGLIGENCE PER SE, AND/OR STRICT LIABILITY, OF STAR OR THEIR RESPECTIVE PRESENT AND FORMER OFFICERS, DIRECTORS, MEMBERS, SUBSIDIARIES, AFFILIATES, EMPLOYEES, STAFF AND AGENTS, AND ANY OTHER PERSON, FIRM OR CORPORATION BOUND TO DEFEND OR PAY JUDGMENTS AGAINST THEM (THE "RELEASED PARTIES"); (II) PERSONAL INJURY, DEATH OR PROPERTY DAMAGE; (III) ACTS UNDER THE TEXAS DECEPTIVE TRADE PRACTICES ACT ("DTPA"); (IV) ACTS OF ANY OTHER PERSONS OR GUESTS; (V) THEFT, BURGLARY, ASSAULT, OR OTHER CRIMES; (VI) FIRE, WATER, WIND, RAIN AND/OR SMOKE AND/OR; (VII) ANY OTHER RISKS AND HAZARDS ASSOCIATED WITH THE UNDERSIGNED'S ENTRY INTO AND PARTICIPATION IN THE ACTIVITIES, INCLUDING, BUT NOT LIMITED TO, THE GENERAL CONDITIONS AT THE ACTIVITIES, ANIMALS BOTH WILD AND DOMESTIC THAT MAY BE DISEASED AND/OR POTENTIALLY DANGEROUS, PERSONS WITH FIREARMS BOTH ON AND OFF THE PREMISES USED IN CONNECTION WITH THE ACTIVITIES, AND THE DRIVING OR RIDING IN ANY VEHICLES, WHETHER BELONGING TO RELEASED PARTIES OR OTHER PERSONS.
2. RELEASE FROM LIABILITY: THE UNDERSIGNED HEREBY RELEASES, ACQUITS AND FOREVER DISCHARGES, AND WAIVES ANY AND ALL CLAIMS AGAINST ANY OF THE RELEASED PARTIES THAT ARISE FROM OR RELATE TO THEIR ENTRY AND PARTICIPATION IN THE ACTIVITIES – INCLUDING, BUT NOT LIMITED TO, THE TYPES OF CLAIMS ENUMERATED IN PARAGRAPH 1—AND AGREE NOT TO SUE ANY OF THE RELEASED PARTIES FOR SUCH CLAIMS. WITHOUT LIMITING THE FOREGOING, THE UNDERSIGNED AGREES THAT THE RELEASED PARTIES SHALL NOT BE LIABLE TO THEM, THEIR FAMILY, OR THEIR GUESTS, FOR PERSONAL INJURY, PROPERTY DAMAGE, OR ANY OTHER CLAIMS ARISING FROM OR RELATED TO THE UNDERSIGNED'S ENTRY INTO AND PARTICIPATION IN THE ACTIVITIES.
